As regards research I mainly work in four areas within the context of Latin American Studies and in comparative terms with European Studies, as follow: (i) Cultural Studies, (ii) Science Studies, (iii) Visual Arts and Cinema and (iv) Semiotics, Philology and History of Books (see www.canaparo.org/Pdf_files/Research_plans/Areas_of_Research.pdf). According to the projects and periods, I alternate publications in all these areas. The entanglement of these different areas of research is of great importance as I believe it allows me to have a truly interdisciplinary approach (see www.canaparo.org/Projects/index.shtml).

At the moment I am working in an authored monograph that constitutes an in-deep analysis of how cultural evolution can be explained by looking at the conceptual definition of space, land and territories. I am also working in a monograph (almost finished) that should briefly present all the theories regarding the 'spatial' interpretation of Latin American culture and its relation with the contemporary notion of colonialism.
